Roles and responsibilities

- To provide an elite physiotherapy service for the first team squad, ensuring effective management of all professional players with regards to their medical needs.
- To provide assessment, treatment and rehabilitation of the first team squad players.
- To ensure the management of injuries effectively meets its commitments to the players, coaches and senior management, by self-critiquing and accurate documentation (in alignment with CSP code of practice).
- To work alongside the Strength & Conditioning/Sport Science team in order to deliver effective individualised injury prevention strategies across all players in the senior squad.
- To collaborate with the Strength and Conditioning team in delivery individual development programmes (IDP) to all first team players, including individual and group sessions.
- To provide physiotherapy match day cover for first team games as required by the Physiotherapy Manager.
- To assist in the organisation of medical provision for all training camps for the first team squad in conjunction with the Physiotherapy Manager.
- To work alongside the Strength & Conditioning/Sport Science team in order to deliver first class recovery and injury prevention strategies to all players both immediately after games and on recovery days.
- To ensure all players are educated on the importance of recovery.
- To actively use objective data when available to quantify when players are returning to full fitness / returning to team training.
- To assist the Physiotherapy Manager with injury audit analysis, to provide accountability for the department and actively driving forwards best practice.
